Q&A Platform update and categorisation of questions received

Cover Note

Objective

- 1 The objective for this session is to review and approve the next two batches of suggested categorisations.
- 2 In advance of today's meeting, the SRB has received the second and third list of suggested categorisations for review. The second list (06-02) is the same list as included in the meeting of the 29 November 2023. The third list (06-03) is an additional batch of categorisations. Both lists are subject for approval in this meeting.

Background

- 3 On the 23 November 2023, the SRB approved the first batch of categorisations (38 questions). In advance of the meeting of the 29 November, the SRB received the second batch of categorised questions (21 questions).
- 4 In SR TEG meeting of 5 December, no objection was raised to the categorizations of the first batch of questions, which are now considered final.
- 5 In addition, in SR TEG meeting of 5 December, 14 draft explanations of questions in the first batch of categorisations were reviewed and approved, subject to small edits to be made in five of them. The reviewed set of 14 explanations will be sent to the SRB for written approval shortly after the SRB meeting of 13 December.
- 6 As of 6 December, EFRAG has received 164 questions, including 63 related to the crosscutting, 31 to the environment and 32 to the social standards.


