## **Veronique Blum**

Véronique BLUM is an Associate Professor in Corporate Finance and Accounting in Université Grenoble Alpes. She obtained a PHD in Management Sciences from Université Paris Ouest La Défense.

She is also a member of the EFRAG Academic Panel, member of the MIAI - Multidisciplinary Institute in Artificial Intelligence in Grenoble, member of the Human Enterprises. At the Association Francophone de Comptabilité, she cochairs a working group dedicated to Intangibles.

Her research, published in international journals such as Ecological Economics, Accounting, Auditing and Accountability Journal or Critical Perspectives on Accounting is focused on valuation methodologies, and more specifically on applications to intangibles and decision under uncertainty. She also is a member of several scientific societies and the President of a unit of the Chartered Public Accountant national exam.

Véronique started her career as a consultant in Internal Control in private organizations with a state delegation and worked for companies such as Renault, Cogema, or Decathlon. She currently acts as a valuation expert and chairs the IP Valuation Committee of LES France.

As well as being widely published in international journals across accounting, finance, and economics, Iain a key contributor to pension policy and practice and an expert advisor to a range of businesses, policy makers and organisations. He is also part of the consortium, led by the Smith School for Enterprise and Environment at the University of Oxford, with Imperial, Reading and Bristol, that is building the £10m UK Centre for Greening Finance and Investment. A central feature of Iain's research is its translation to practice,

and it has been used to advise a range of businesses, regulators, and policy makers both in the UK and internationally. He has advised organisations including, The CERN Pension Fund, The City of London Corporation, The Work Foundation, The Pensions and Lifetime Savings Association, Aon, The Office for National Statistics, and the Financial Conduct Authority.

Guy Jubb, is a member of the Institute of Chartered Accountants of Scotland (ICAS), and is Chair of its the Research Panel and a member of its Policy Leadership Board. Erlend Kvaal is professor of accounting at the BI Norwegian Business School. Before joining academia, he was for a number of years a civil servant at the Norwegian central bank and the Norwegian ministry of finance. He was chair of the Norwegian Standard Setter, NASB. He is currently member of EFRAG Technical Expert Group and the EAA Financial Reporting Standards Committee. Erlend is Chairman of the EFRAG Academic Panel.



# **Sue Lloyd**

Sue Lloyd was appointed as Vice-chair of the International Accounting Standards Board (Board) in October 2016, having served as a Board member since 2014. She was reappointed as vice-chair in April 2018 for a term of five years starting 1 January 2019.

She was appointed the Chair of the IFRS Interpretations Committee in February 2017 and continues to serve.

Prior to joining the Board, Sue worked for the organisation as a senior technical director, leading the development of new IFRS Standards, and as director of capital markets with responsibility for the Board's reform of accounting for financial instruments.

Sue also worked for the organisation from 2002 to 2004 as a technical project manager. She has held various positions in investment banking both in the UK and in Australia and has served as a member of the Australian Accounting Standards Board (AASB). She has a master's degree in accounting and finance from the University of Auckland in New Zealand.











#### Giovanna Michelon

Since June 2019, Giovanna Michelon has been Professor of Accounting at the University of Bristol in the UK. Before that she was at the University of Exeter Business School for six years. She started her career at the University of Padova, in Italy, where she also obtained her PhD. She has held visiting positions at Concordia University (Canada), University of Central Florida (USA), ESSEC Business School and Université Toulouse Capitole (France). Giovanna is a well-

established international scholar in the field of corporate governance and sustainability accounting and reporting, with more than 40 publications in leading academic journals. Her work has explored how corporate governance drives corporate social responsibility activities and reporting, and the role of sustainability information for market participants and other stakeholders.

Highly engaged with both the academic community and practitioners, Giovanna is currently Editor of Accounting Forum, Chair of the *European Accounting Association (EAA) Virtual Activities*Committee, and a member of the *EAA Management Committee and EAA Publications Committee*. She is also Chair of the *ACCA Global Forum for Governance*, *Risk and Performance* where she helps setting the research agenda of this professional body in the fields of corporate governance and risk management.



## Mari Paananen

Mari Paananen is an Associate Professor of Accounting at the University of Gothenburg. Mari's research interests are generally in the field of capital market implications of accounting using computerized text analysis, the economic impact/consequences of social networks and the magnitude and reasons for earnings management among small and medium sized (SME) companies. As a part of the use of text analysis in conjunction with traditional numbers in financial

reporting, she has recently been involved in several research projects examining the reporting practices and valuation of environmental liabilities funded by the IAAER KPMG grant program to inform the IASB and the Institute of Chartered Accountants of Scotland (ICAS). She is currently associated editor of the Journal of Applied Accounting Research and on the editorial board of Accounting in Europe and the Journal of International Accounting, Auditing & Taxation. Mari also served as the research fellow at the European Financial Reporting Advisory Group (EFRAG) in 2017 and 2018.
