Planning of the transition

- The work in project mode by the PTF ESRS will continue till the finalisation of the bases for conclusions aiming for publication by the end of May
- Public consultation period on Exposure Drafts on first set of draft ESRS (EDs) with deadline 8 August
- Work remaining outstanding
 - Set 1: Cost-benefit analysis
 - Set 1: Digital guidance first set of draft ESRS
 - Set 2: Research and preparation as started under the PTF-ESRS, to continue during the public consultation period. Detailed planning on the discussion and approval of set 2 to be provided at a future meeting.
- (Expert) Working Groups (EWGs): to continue but composition could be extended, if needed new Working Groups can be created



Transition period


- EFRAG SRB and EFRAG SR TEG to become familiar with and form views on the EDs
 - As from the beginning of the public consultation period
 - Joint educational sessions with EFRAG SRB
 - Involvement of Cluster leads of the PTF ESRS to provide background and respond to questions in educational sessions
 - A series of one-hour educational sessions to cover each ED
 - EFRAG SRB and EFRAG SR TEG members are invited/expected to contribute to the organisation of and participate in the outreach events during the public consultation period (May/July), together with members of the PTF ESRS



Decision-making process

- EFRAG SRB to provide direction to the EFRAG SR TEG
 - EFRAG SRB is responsible for all positions, after having considered the technical advice provided by EFRAG SR TEG and reflecting the results of EFRAG's due process
- EFRAG SR TEG to provide advice to the EFRAG SR Board, within the directions indicated by the EFRAG SRB, and taking into account the results of the public consultations
- EFRAG SRB to decide on draft ESRS to be submitted to the EC

Timeline for the finalization of Set 1






EFRAG SR TEG meetings in 2022
