Draft ESRS Road Transportation working paper (pre V1)

Background and objective

- 1 During the EFRAG SR TEG meeting held on 7 March 2023, SR TEG received an overview of the first draft of ESRS working paper on Road Transportation, which constitutes the basis for the future V1.
- 2 In this session the EFRAG Secretariat will introduce the process followed to develop this [draft] ESRS working paper for Road Transportation (pre V1) and will illustrate the related main proposed disclosure requirements. This draft does not include (yet) the social part.
- 3 In developing this [draft] ESRS working paper for Road Transportation (pre V1), the Writing team has followed the approved methodology to select the sustainability matters (defined in the summer 2022) and the approved decision tree for sector standards (defined for MQC and OG ED).
- 4 This [draft] ESRS working paper for Road Transportation has not yet been reviewed by the Central EFRAG Secretariat and is therefore still subject to considerable changes, including moving of ARs to front part of document.
- 5 The proposal on the social part is still working in progress and a preview will be presented during this SR TEG meeting.
- 6 The presentation is run jointly by EFRAG Central Secretariat and which Writing team members who have worked on Road Transportation during 2022 and 2023. The Writing team will present a suite of documents to SR TEG for discussion purposes.
- 7 All documents presented are in draft and are part of an ongoing development and review process which includes continued engagement with external stakeholders.
- 8 There are some specific questions for SR TEG members in this session and the documents uploaded for the session will also serve as a basis for the discussion to be held.
