Q&A Platform approval of categorisations and explanations

Cover Note

Objectives

To review and approve the latest batch of categorised questions approved by the SRB (paper 05-02 – late upload) and agree on a new batch of explanations (paper 05-03 – late upload).

Background of the EFRAG discussions

- As of 14 May 2024, EFRAG has received 439 questions: 156 related to the cross-cutting, 124 to the environment, 79 to the social standards and 14 to the governance standards.
- Approval of categorisations: The SRB has approved two further batches of categorizations in its recent meetings, the final comments will be received on 16 May 2024, resulting in a late upload for SR TEG meeting. These categorizations are presented in paper 05-02 for final approval.
- 4 A further batch of explanations has been prepared for discussion and approval at SRT level (paper 05-03).
- If the SR TEG has objections to any of the categorisation (paper 05-02) or explanations (paper 05-03), these should be voiced in the meeting or sent to EFRAG Secretariat as a written objection in advance of the meeting, mentioning ID number of the categorisation and proposed adjustment to the categorisation. 9 Categorisations agreed by SR TEG will be final and published on the weekly log of questions at EFRAG's website.




