Objectives

- To review on a non-objection basis the latest batch of categorisations approved by the SRB (paper 06-02).
- 2 To review and approve new batch of draft explanations (paper 06-03).

Background

- As of 13 June 2024, EFRAG has received 475 questions: 169 related to the cross-cutting, 141 to the environment, 81 to the social standards and 13 to the governance standards.
- Approval of categorisations: The SRB has approved a new batch of categorizations in its meeting of 12th June 2024. These categorizations are presented in paper 08-02 for final approval. [Please note that the draft explanation of ID 698 was already sent to SR TEG for approval in the meeting of 18 June, pending final approval of its categorisation.]
- If the SR TEG has objections to any of the categorisation (paper 06-02), these should be voiced in the meeting or sent to EFRAG Secretariat as a written objection in advance of the meeting, mentioning ID number of the categorisation and proposed adjustment to the categorisation. In the latter case, please mail to a-nd-a-platform@efrag.org.
- Approval of explanations: Three new draft explanations are included in paper 06-03 for review and approval.
