Q&A Platform approval of categorisations and explanations Cover Note

Objectives

- To review on a non-objection basis the latest batch of categorisations approved by the SRB on June 26 (paper 06-02).
- 2 To review on a non-objection basis the next batch of explanations (paper 06-03).

Background

- As of 10 July 2024, EFRAG has received 518 questions: 189 related to the cross-cutting, 153 to the environment standards, 86 to the social standards and 13 to the governance standards.
- Approval of categorisations: The SRB has approved a new batch of 25 categorizations in its meeting of 26th June 2024. These categorisations are presented in paper 06-02 for final approval.
- Approval of explanations: The SR TEG parked/objected explanations in the meetings of June 18 and June 20. These explanations are presented in paper 06-03 for further discussion together with new explanations.
- If the SR TEG has objections to any of the categorisation (paper 06-02) or explanations (paper 06-03), these should be voiced in the meeting or sent to EFRAG Secretariat as a written objection in advance of the meeting, mentioning ID number of the categorisation and proposed adjustment to the categorisation. In the latter case, please mail to q-and-a-platform@efrag.org.
